MINUTES ELKHART COUNTY COUNCIL December 11, 2010

The meeting of the Elkhart County Council was called to order by Sheriff Elect Brad Rogers at 8:00 a.m., in Room 104 of the County Administrative Building, Goshen, Indiana. Members present were John K. Letherman, Dennis E. Sharkey, Donald E. Abel, C. J. Yoder, Randall D. Yohn, David Foutz and David Ashe.

Also present were David Hess, County Auditor; Pauline Graff, Chief Deputy Auditor; Gordon Lord, County Attorney; Craig Buche, County Attorney; Tom Byers, County Administrator; Mike Yoder, Commissioner; and Floyd Hindbaugh, Director of Personnel.

MINUTES: Approval of minutes for November 13, 2010.

On motion made by Sharkey seconded by Yohn and unanimously carried, the minutes of the November 13, 2010 Council meeting were approved as received.

COMMITTEE REPORTS:

COMMISSIONERS: No report.

COUNCIL: Abel let the Council know he would miss them and expressed his

appreciation in working with the Council over the last twelve years. Yoder stated that it has been a great experience working with the Council the last eight years. He feels it has been a learning experience and great way to find out how county government works. He hopes that the public would come and participate in the Council meetings more often. He also hopes the Council will continue to spend wisely and pay as you go as much as you can. He feels the County is in great financial shape compared to other counties. He wished the council the best. Ashe, Yohn, Foutz and Sharkey thanked Yoder and Abel and expressed their appreciation for their service. Sharkey presented a certificate to Yoder for his work on the personnel committee the last eight years. Letherman presented service awards to Yoder and Abel for their hard work and service to the people of Elkhart County. Letherman also presented an award to Hess for his thoughtful support and expert advice to the Council as Auditor the last seven years.
